### WHAT TYPE OF INVESTMENT IS THIS?

The Fund is an unregistered unit trust under Australian law. Investment in the Fund is limited to investors who are 'wholesale investors'.

### WHAT CAN THE FUNDS INVEST IN?

The Funds will predominantly invest in an underlying security of registered first mortgages. The exposure of the Fund will be limited to investments of 55% of the value of each security property, as assessed by independent valuation.





## KEY TERMS OF THE OFFER

Some of the key terms of the offer of an investment in the Funds are:

- + **Properties:** Located on the east coast of Australia.
- + **LVR exposure:** Limited to 55% of the property value.
- + **Target Return:** 7% per annum (net to investor) paid semi-annually.\*
- + **Initial Investment Term:** 12 months-thereafter redemptions can be made on 90 days notice.
- + **Minimum investment:** Applicants must make an initial investment of at least \$500,000 (Subject to manager discretion).
- + **Fund of Fund investment:** Allowed.
- + **Currency:** AUD
- + **Investor Profile:** Wholesale Clients who do not require income to be paid more frequently than semi-annually.
- + **Types of investment:** Fund of Fund and direct loans -underlying security is a registered first mortgages supported by collateral securities.
- + **Distribution Dates:** The Trustee will pay distributions semi-annually (within 90 days of 30 June and 31 December each year).
- + **Reports:** Investors will receive quarterly performance reports.
